

THE COATES HIRE PRIZE PACK GIVEAWAY (“PROMOTION”)

TERMS AND CONDITIONS (“CONDITIONS”)

PROMOTIONAL PERIOD

1. Entry is only open to residents of Australia aged 18 years or older (**Entrants**).
2. The Promotion starts on **the** date of issue of an email by the Promoter advising an Entrant of their eligibility to enter into the Promotion (**Eligibility Email**) and expires twenty (20) business days after the Eligibility Email was issued or until stock runs out, whichever is the earliest (**Promotional Period**).

HOW TO ENTER

3. To enter the Promotion, Entrants must, during the Promotional Period:
 - a) Make a general hire purchase from a Coates Hire branch (**Eligible Purchase**).
 - b) Entrants must act in accordance with the Promoter's trading terms throughout the Promotional Period.
